



2. PLACE OF BUSINESS

The principal place of the partnership business will be situated at Vill Mr. Bazar, Plassey, Netajee Market, Kaliganj, Nadia, West Bengal: 741156. The partnership firm shall open their branches at any place in India as required.

3. DURATION OF PARTNERSHIP

7. MANAGEMENT

11. ACCOUNTS

The firm shall regularly maintain in the usual course of business, true and correct accounts of all its transactions and also of all its assets and liabilities, the property books of account, which shall be kept at the firm's place of business.
